

## LEAVING A LEGACY

### How to Make a Bequest to PRASAD® Australia

Many individuals choose to provide for a gift to a charitable organisation or a cause that is meaningful to them in their Will.

It is simple to provide for such a gift to PRASAD® Australia.

The form of words to be used varies slightly according to the type of gift you wish to make -- whether it is a specific dollar amount, a valuable item like a painting or jewellery, or a % of assets or real estate, or from an insurance policy.

The following suitable forms of words for different kinds of gifts may be provided to your legal adviser, or inserted into your Will for this purpose:

**1. I GIVE AND BEQUEATH to PRASAD® AUSTRALIA of 92 Roland Avenue, Wahroonga, NSW, 2076, Australia (PO Box 723 Wahroonga, NSW, 2076)**

for its charitable purposes free of all duties and taxes payable in consequence of my death:-

- The sum of \$ ..... or
- The whole of the proceeds of my Life Insurance Policy No: ..... with ..... (name of insurance company).  
(PRASAD® Australia will need to be nominated in the Insurance Policy as the beneficiary.)  
or
- The whole of the proceeds of the Policy of Insurance on the life of X, being Policy No: ..... with (name of insurance company).  
(PRASAD® Australia will need to be nominated in the insurance policy as the beneficiary)  
or
- The following shares (set out details of the shares)  
or
- Paintings or jewellery or other items of value  
or
- My property at (include the address of the property)

\*\* I DECLARE that a receipt issued by the Treasurer or other proper officer for the time being of PRASAD® Australia shall be a full and sufficient discharge to my Executors and Trustees.

**OR**

**2.** I GIVE DEVISE AND BEQUEATH to PRASAD® AUSTRALIA of 92 Roland Avenue, Wahroonga, NSW, 2076,

for its charitable purposes free of all duties and taxes payable in consequence of my death:-

- The whole of my Estate or
- The residue of my Estate or
- ..... Percentum of my Estate or
- ..... Percentum of the residue of my Estate

I DECLARE that a receipt issued by the Treasurer or other proper officer for the time being of PRASAD® Australia shall be a full and sufficient discharge to my Executors and Trustees.

**Note:**

Under Australian law, should **PRASAD® Australia** cease to exist, a court can decide such a bequest be made to a charity “of a similar kind.”

To remove any doubt, however, you may wish to include a statement that should this occur, then the bequest will go directly to **PRASAD Chikitsa** in India.
